

## **1. THE REGULATIONS**

- 1.1. Upon arrival, Guests are required to fill in the Notification Form and hand over their identification card.
- 1.2. Upon acceptance, the exact number of group members must be declared and the equipment to be installed must be specified. Customers are requested to check and immediately report any inaccuracies or changes. Any unreported equipment will be removed immediately at the customer's expense.
- 1.3. The pitch can accommodate only one residential unit.
- 1.4. The assigned pitch cannot be changed without prior authorization from the Management.
- 1.5. Children under the age of 18 are not allowed inside the Tourist Resort unless they are accompanied by their parents.
- 1.6. Adults will be responsible for the damage caused by minors under their care to things or people inside the village, always without prejudice to the responsibility of the adult himself for his own actions. In any case, adults must ensure that the behaviour of their children or minors entrusted to them does not disturb the peace and safety of the Guests of the Tourist Resort.
- 1.7. Visitors and/or day guests are not allowed inside the tourist resort unless they are authorized by the Management.
- 1.8. The Management reserves the right to limit the supply of water in consideration of particular contingencies of availability or by order of the administrative authorities.
- 1.9. Guests are kindly required to observe all the recommendations that may be requested by the Management, in particular situations.
- 1.10. The Tourist Resort Management declines all responsibility for damage caused to people and/or things deriving from the use of the equipment made available to the Guests (for example: games for children, soccer field, tennis etc.), it being understood that such use occurs at the risk of the Guest. The Management also declines any responsibility for damage to things and people as a result of unforeseeable circumstances, force majeure (only by way of non-limiting examples: hail, wind, rain, tornadoes, negligent and/or malicious events by third parties, etc.) or for any fact not attributable to the Management and Staff of the Tourist Resort.
- 1.11. This regulation has been deposited in the municipal offices and will be displayed on the bulletin board. The staff is authorized to enforce it and the Management reserves the right to remove Guests who do not comply with it from the Tourist Resort.
- 1.12. The order, cleanliness and proper functioning of common services are also entrusted to Guests' civil and respectful behaviour.

# 2. FOR THE SAFETY OF THE TOURIST RESORT AND OF ALL ITS GUESTS, WE RECOMMEND:

- 2.1. using fireproof cables is mandatory, in accordance with the law for the electrical connection to the power sockets, ensuring that the system is correctly grounded to the Tourist Resort's earth;
- 2.2. paying the utmost attention when using grills and camp stoves, barbecues are only allowed in the specifically designated area. However, the management reserves the right to prohibit its use in the presence of certain weather conditions;
- 2.3. circulating with cars, campers, caravans, motorcycles and/or other vehicles, strictly respecting the maximum limit of 10 km/h and in any case driving with utmost prudence, respecting the horizontal and vertical signs set up inside the Tourist Resort;
- 2.4. using cars and motorcycles solely to enter and exit the Tourist Resort.

# 3. IN ORDER TO ENSURE A PLEASANT AND SERENE STAY IN MUTUAL RESPECT WE RECOMMEND:

- 3.1. throwing paper and waste in the appropriate containers;
- 3.2. washing linen and dishes in the special equipped areas;
- 3.3. not using fountains, hydrants and/or other water dispensers for personal hygiene and/or cleaning things;
- 3.4. remembering to occupy the shower cubicles for the time strictly necessary (max 4 minutes);
- 3.5. leaving the public toilets in the best possible state after use.

### 4. IT IS STRICTLY FORBIDDEN TO:

- 4.1. light fires inside the Tourist Resort and on its beach;
- 4.2. circulate with bicycles from 2:00 pm to 4:00 pm and from 9:00 pm to 8:00 am.
- 4.3. circulate with motor vehicles from 1:00 pm to 4:00 pm and from 8:00 pm to 8:00 am;
- 4.4. use TV, radio, musical instruments at high volumes, disturbing the quiet of Guests and the Tourist Resort in general;
- 4.5. dig holes, lay fences or place ropes at eye level;
- 4.6. use your own barbecues (use only the designated ones);
- 4.7. cause damage in any way to plants, trees and flower beds;
- 4.8. wash cars, campers, caravans, motorcycles and/or other vehicles inside the Tourist Resort.

#### 5. COMPLIANCE WITH THE FOLLOWING PROVISIONS RELATING TO VEHICLE PARKING IS MANDATORY:

- 5.1. vehicles must be parked only and exclusively in the designated area located on the side of the village;
- 5.2. campers are allowed to access the camping area by car only on the day of arrival and departure for unloading/loading. During your stay, use the

special freight trolleys;

5.3. clients of the small villas cannot access their housing unit by car for loading/unloading.

#### 6. VARIOUS SCHEDULES

- 6.1. Gate Opening: 08:00 am 12:00 am
- 6.2. **Quiet time:** 2:00 pm 4:00 pm / 12:00 am 08:00 am. During that time, noises that could disturb guests are strictly prohibited, including setting up, dismantling tents and moving vehicles.
- 6.3. Cash desk hours: 08:00 am -1:00 pm / 2:00 pm 7:00 pm
- 6.4. Departure time: pitches by 12:00 pm villas by 10:00 am

### 7. SPECIFIC REGULATIONS FOR DOG OWNERS

- 7.1. Animal owners are obliged to take them outside the tourist resort to the specially designated area, to do their business. Animals are not allowed inside the tourist resort if they are not on a leash.
- 7.2. All dogs must be microchipped and registered in the canine registry of the region they belong to.
- 7.3. They must be kept on a leash in public spaces with a maximum length of 1.5 meters, a muzzle must also be available to be used when instructed by the competent bodies and management where this is competent.
- 7.4. As an exception to the previous point, dogs may be released inside the walking area and on the stretch of water in front of the dog beach, while the owner or keeper still has the civil and criminal liability for damage caused by their pet to people, animals, or things.
- 7.5. It is mandatory to pick up solid manure.
- 7.6. Always ensuring drinking water available to your pet is mandatory.
- 7.7. While on the beach, the owner is required to let his dog walk (at least every 3 hours) in the woods adjacent to the beach.
- 7.8. Inside the structure it is forbidden to walk with the dog on the marked green areas designated to people.
- 7.9. It is also forbidden to allow pets to climb onto the beds within the tourist resort facilities.

# The management reserves the right to remove any repeat offenders at any time of the stay.
